

## TAB NZ Football Jersey Giveaway - Terms and Conditions

1. All Entrants (“**Entrants**”) who participate in this TAB NZ Football Jersey competition (the “**Competition**”) are deemed to accept these terms and conditions of entry. Any entries in this Competition that do not comply with these terms and conditions will be deemed invalid and Entain New Zealand Limited (“**TAB NZ**”) takes no responsibility for such entries. All times given in these terms and conditions are references to New Zealand Local Time and all references to currency are referring to New Zealand Dollars.
  - a. This Competition is not endorsed by or associated with Meta.

### Competition Period

2. The Competition will commence on 25 June 2026 at 12:00pm and conclude on 27 June 2026 at 3:00pm (the “**Competition Period**”).

### Eligible Entrants

3. To be eligible for entry into this Competition all Entrants must:
  - (a) Be residing in New Zealand and eighteen (18) years of age or over from the time the Entrant first participates in the Competition during the Competition Period; and
  - (b) Follow TAB NZ on Facebook or Instagram,
4. TAB NZ reserves the right to require any Entrant to produce identification to verify their age or identity.

### Competition Entry

5. An Entrant will earn a Competition Entry (a “**Competition Entry**”) by liking TAB NZ’s competition social media post on Facebook or Instagram and commenting their prediction for the final score between Belgium and New Zealand playing on 27 June 2026 on that post.
  - a. Only one entry may be earned per person (entering across both Facebook and Instagram will only count as one entry).
6. An Entrant must also tag at least one friend in their entry comment on the competition social media post.

### Prize Draws

7. After the completion of the Competition Period, at or about 12pm on 29 June 2026, TAB NZ shall review the submitted entries and determine the prize winners. Entries validly submitted per these terms will be entered into a pool and will be selected to be prize winners by random lot; the prediction’s accuracy does not affect the chances of being drawn. The final decision in respect of the Prize Draw will be at the sole discretion of TAB NZ and no correspondence will be entered into.

## **Competition Prize**

8. Each Prize Winner will win one (1) custom TAB Football Jersey, similar in make and design as featured in the image attached to the competition social media post (each a **Prize**). Each Prize is worth approximately \$80. Limited sizes are available, and a Prize Winner may not receive the size that best fits them.
9. The benefit described as the Prize is the entire prize; there are no other inclusions whatsoever unless expressly stated otherwise in these terms.
10. There will be only one (1) Prize Draw, during which ten (10) entries will be randomly drawn, and there are only ten (10) Prizes to be won.
11. If the Prize (or any part of the Prize) is unavailable for any reason, TAB NZ, in its sole discretion, reserves the right to substitute the Prize (or part of the Prize) with a prize to the equal monetary value. The Prize, or any unused portion of the Prize, cannot be exchanged for cash or other products or services, or otherwise transferred or modified.
12. TAB NZ will contact the Prize Winners via direct message on Facebook or Instagram. TAB NZ reserves the right to verify the Prize Winner's age and identity.
13. Each Prize Winner must arrange delivery and receipt of the Prize. TAB NZ will pay for basic shipping provided that the Prize Winner's nominated address is in New Zealand. Otherwise, the Prize Winner must bear all costs associated with shipping.
14. If TAB NZ is unable to contact the Prize Winner by 12pm on 13 July 2026, having made reasonable efforts to do so, their entry will be declared invalid and TAB NZ reserves the right to redraw another Prize Winner on the same terms and conditions as the original Prize Draw or retain the Prize.
15. TAB NZ takes no responsibility if any Prize Winner is unable to use the Prize for any reason whatsoever, including if a Prize is lost in transit.

## **General**

16. The Prize Winner agrees to be involved in any reasonable promotional activities stipulated by TAB NZ (without compensation), including but not limited to photographs, the publication of the Prize Winner's name, place of residence, and any images. TAB NZ will own the copyright in any such images and photograph(s) and in all material incorporating the photograph(s) or film.

TAB NZ reserves the right, at any time, to verify the validity of any Competition Entry, or Prize Draw, and to disqualify as ineligible to participate in the Competition, in any way, any Entrant who acts in a manner that is not in accordance with these terms & conditions, or who tampers with the eligibility process or attempts to act in a fraudulent or dishonest manner.
18. The following persons are not eligible to enter this Competition or win the Prize:

- (a) TAB NZ Board members, employees, agents (and agent's employees) and contractors of TAB NZ and the "Immediate Families" of such persons.
19. For the purposes of condition 18, the "**Immediate Family**" of a person are the parents, siblings, children and spouse or partner (whether legal or de facto) of that person (and "Immediate Families" shall have a corresponding meaning).
  20. If this Competition cannot be run as planned for any reason, including for reasons beyond the control of TAB NZ, TAB NZ reserves the right in its sole discretion to cancel, terminate, modify or suspend this Competition (or any part of this Competition), at any time.
  21. TAB NZ takes no responsibility for any inability to enter, complete, continue or conclude the Competition (or any part of the Competition) due to equipment or technical malfunction, Acts of God or otherwise.
  22. Except for any liability that cannot be excluded by law, TAB NZ and any person in connection with this Competition are not liable for any direct, indirect, special or consequential loss or damage whatsoever suffered or personal injury suffered or sustained in connection with:
    - (a) Registration for or participation in this Competition;
    - (b) The use (or non-use) of the Prize; and
    - (c) The administration of this Competition.

    - (b) Ensure fairness and the integrity of this Competition;
    - (c) Provide you with notifications, reminders and offers;
    - (d) Assess your eligibility to receive specific products and services;
    - (e) Offer you products or services that TAB NZ considers may be of interest to you;
    - (f) Assess your eligibility for participation in any promotional events which TAB NZ may be running;
    - (g) Carry out general market research and analysis relating to TAB NZ's products and services generally;
    - (h) To invite you to participate in surveys, sweepstakes, Competitions and similar promotions
  25. TAB NZ may match or combine the personal information that you provide when entering this Competition with other personal information about you that TAB NZ has obtained from other sources or that may already be on TAB NZ's records, whether that information was collected

online or in physical form, and may use information already held in the administration of this Competition.

26. Pursuant to the Privacy Act 2020, you have the right to view the personal information you have provided when entering this Competition. You may also request to review and correct any of that personal information by contacting TAB NZ. Additional rights may apply under applicable law.
27. By entering this Competition, an Entrant agrees to receive marketing and promotional material from TAB NZ and its authorised agents (including electronic material).
28. Entrants into this Competition agree that TAB NZ may disclose the Entrant's personal and Competition Entry information to third parties in connection with any of the purposes stated under condition 24, provided the recipient of the information is subject to an obligation of confidentiality in relation to the disclosed information.
